With effect from the said date, the Central Council of Indian Medicine constituted under sub-division (1) of section 3 of the Indian Medicine Central Council Act, 1970 (48 of 1970) shall stand dissolved. Now, in exercise of the powers conferred by subsection (3) of the section 1 of the said Act, the Central Government hereby notifies that all the provisions of the National Commission for Indian System of Medicine Act, 2020 has been come into force with effect from the 11th day of June, 2021 and as per regulation 59 (2) of The National Commission for Indian System of Medicine Act, 2020, Medical standards, quirements and other provisions of the Indian Medicine Central Council Act, 1970 and the rules and regulations made there under shall continue to be in force and operate till new standards or requirements are specified under this Act or the rules and regulations made there under. Further, the provision of concerned regulations which are inconsistent with the provision of NCISM Act, 2020 shall not be applicable.

- Further, to assess the available facilities of teaching, non-teaching, Hospital staff, practical training and other infrastructure facilities at your college namely Shree Dhaneshwari Manav Vikas Mandal, SouShanta devi Vedprakash Patil Ayurved College & Research Institute, Gat No. 421, Hatta, Tq. Basmat Dist. Hingoli – 431705 Maharashtra (Inst. Id- AYU0327) inspection of your College was conducted on 29.05.2023 & 30.05.2023 on Hybrid mode as a part of annual visitation by the visitation team of Medical Asessment and rating Board, NCISM to process the Conditional permission with 100 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24.
- Further, the visitation report and all other related documents were assessed in terms of the enforced regulations namely, the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016", provisions under the NCISM Act, 2020 and relevant Regulations there under.
- 3. As per the direction of President, Medical Assessment and Rating Board for Indian System of Medicine (NCISM), the assessment report was placed in the 49th Board meeting of Medical Assessment and Rating Board for Indian System of Medicine (NCISM) held on 27.07.2023. On careful examination of the assessment report it is found that your college is fulfilling the notified & approved criteria, hence Board decided to issue the Conditional permission with 100 seats in UG (BAMS) course under section 28 of NCISM Act, 2020 for the academic session 2023-24.
- 4. Therefore, conditional permission is granted to Shree Dhaneshwari Manav Vikas Mandal, Sou Shantadevi Vedprakash Patil Ayurved College & Research Institute, Gat No. 421, Hatta, Tq. Basmat Dist. - The following requirements should be fulfilled by the college by 31st December, 2023 and send a 7. compliance report to get permission for the academic session 2024-25:
 - all the requirements of Minimum Standard of infrastructure and teaching & training facilities as specified in i) Regulation 3 of the "Indian Medicine Central Council (Requirements of Minimum Standard for undergraduate Ayurveda Colleges and attached Hospitals) Regulations, 2016;
